<p><b>Goleta Meeting</b></p> <p>Dennis and Mark attended.</p> <p>The new F.S. superintendent was introduced, Kevin Elliot. He appears to be focused on forest maintenance, including logging and thinning of the forest. Especially the deceased trees.</p> <p>He is supportive of the CCMA and its efforts.</p> <p>Mt Pinos district is struggling to organize the volunteer groups. Tony Martinez has been made the permanent head of the district. He was the temporary head for the last year or so.</p> <p>The meeting was a joint meeting of motorized and non motorized users. It's interesting to note that the two groups found some common ground in both having similar complaints about the bureaucracy to do needed repairs and expansion of forest usage.</p>	<p>Dennis Law</p>

So we are only allowed to do level one repairs and maintenance until that survey can be done.</p> <p>Level one allows water bar and basin clean out with equipment. It may be done before 5/1 which is the end of the bird nesting season.</p> <p>Bruce has arranged for the student group to return for some hand implement trail work in Mid April.</p> <p>It was decided that we would have two trail maintenance days this month.</p> <p>3/10 Saturday at 9:00 meet up at Turkey Flats. Bring hand tools for digging. Folding shovels.</p> <p>3/18 Sunday at 9:00 meet up at Navajo Flats</p> <p>Both days would be to clean out the catch basins and firm up failing water bars.</p>	<p>Dennis Law</p>
