<p>Trail Status</p> <p>High Mountain Road update: We have been awarded a \$77,000 grant to organize the repairs of the road. It would be made passable for high ground clearance vehicles (4x4). We received a competitive bid from Switzer excavating and are awaiting the Counties blessing to go forward. This is an interim repair not a long term solution.</p>	<p>Dennis Law</p>
<p>Grants</p> <p>We have been awarded two County grants. totaling approximately \$45-\$50,000. This money is for trail maintenance and studies that are a necessary part of that maintenance. Getting clearance to do trail repairs is becoming an issue with new faces at the Forest Service.</p> <p>With some of the remaining RTP Grant money we are considering the purchase of an 18" bucket for the mini excavator. There is also some County money available for the ongoing signage project at Pozo.</p> <p>During this grant cycle we applied for funds to cover the purchase of a water buffalo trailer and a walk behind compactor.</p> <p>We need to do a few trail maintenance days in order to "match hours for funding". Bruce suggested maybe 4 or so days with as many participants as we can inspire.</p> <p>The restrooms at Ballinger Canyon have received further funding and is making it's way through the permitting maze.
